2010 PHASE III ROAD REPAIRS

The final phase of the three year road repair project will get underway this week. The roads that will receive repairs are:

This will end the three year road repair project that was designed to prepare the roads in Tuscawilla for a complete overlay beginning in the year 2014. For the next four years, capital reserve funds will be accumulated in anticipation of the first phase of a three phase overlay of Tuscawilla Roads. Presently, each phase of that project is projected to cost approximately \$325,000 per phase (dependent upon asphalt prices). Minor repairs will, of course, continue to be made as necessary between now and the year the project begins.

SPEED HUMPS SCHEDULED FOR INSTALL WITH ASPHALT REPAIR PROJECT

For those who lived in Tuscawilla in the year 2004, you may recall the call of the Community and the Board's approval of speed bumps for the community. The speed Bumps that were originally purchased at that time unfortunately were not the types that are "approved" by the transportation department (too high). And they were plastic and "removable". The roads were also in poor condition at that time, so the concerns about spending the money to install, and then having to take them out for paving, as well as problems they may create for the snow plows, were well founded.

Since that time, we have re-sold the original speed bumps and have done our homework and footwork to not only prepare the roads for a "permanently installed speed HUMP" but also make sure that the type being installed would comply with the bus transportation department's requirements and not interfere with snow plows.

Unfortunately, speeding in the community continues, and has in fact increased. More and more complaints continue to be received and the Board has determined that the speed humps must be installed.

The good news is that because we are installing them at the same time as the road repair project, we will actually save money and come in under budget on the road repair project even after the speed humps have been installed.

At every Speed Hump location the asphalt will be milled down one inch in depth and each speed hump will be installed the full width of the road, 4" high (only 3" above the asphalt) and each will be 30" wide and painted yellow. Warning signs will be posted approximately 40' feet before the speed hump in both directions.

Initial speed hump locations will be:

2 on Lindsey Dr one before Carrell & one before New Castle

1 on Tuscawilla after Barbary (but before New Castle)

1 on Tuscawilla before Lexington

1 on Tuscawilla after Central Postal Station but before the turn at the bottom of the hill (across from apartments)

1 on Tuscawilla after the turn (heading out toward 51) just past Newington

1 on Tuscawilla before Handi Stop where the (bird sanctuary sign is)

2 on Tall Oak one coming up the hill and one between Berkeley Dr & Bradford Ct

2 on Packet one just after Sunlite and one just before Webhannet (coming from Tuscawilla)

If speed does not calm after the initial install, more speed humps will be installed.

Please remind the drivers in your family and your guests not to speed and that within the next three weeks, speed humps will be in place.

Yard Waste Recycling

The fall yard waste recycling project is scheduled for **ONE DAY ONLY**



Residents are asked to bag their yard waste in RECYCLABLE BAGS ONLY – NO PLASTIC BAGS will be accepted, although you may bring your leaves in plastic bags, dump them and take home your plastic bags. RECYCLABLE BAGS can be purchased at Home Depot or Wal-Mart at a reasonable cost. Please stock up now to be prepared to take advantage of this service this November.

PROPERTY IMPROVEMENTS

Most of you know that Tuscawilla does not have a formal architectural review process.

However, there are a few restrictions in the covenants that must be adhered to and are being overlooked by some homeowners.

All improvements to your property must meet the setback requirements as

outlined in the covenants and as required by the county

Building permits are required by the county for improvements to your property. Make sure you obtain yours.

ALL swimming pools, over 18" MUST be placed inside a 4 ft fence or the side wall must be 48" high with a removable ladder or "locking" ladder.

Sheds MUST be on a permanent foundation. If yours is not you need to remedy that now.

Do not store or build anything in the common areas, utility easements or right of ways. You will be required to move it.

Sheds, decks, fences and other improvements must be maintained. That means painting, staining, repairing, etc.

ADDITIONAL SECURITY LIGHTING BEING CONSIDERED FOR THE PARK

Unfortunately, signage and towing is not enough to keep trespassers away from the park after dusk.

Teenagers and young adults are still going to the park after dark and staying "inside" their vehicles to avoid being towed. Reports received from neighbors around the park indicate the activities are inappropriate and often appear to be illegal. Other options being considered are the "Mosquito" that you may have heard about on the news recently. All remedies are expensive and the Board is seriously considering all options, in addition to the budget, before making a decision.

PLEASE remind your teen drivers and their friends, there is no parking at the park after dusk and before dawn. Parking is not allowed on the "homeowner side" of the street or in the grass.
